Aduro Photography

1. WEDDING PHOTOGRAPHY ORDER: This signed Contract constitutes an order for wedding photography in the form of photographs, proofs and digital files. There are no oral or other agreements of the parties hereto and this Contract constitutes full and complete understanding and agreement between the Client and the Photographer.
2. LIMIT OF LIABILITY: Although care will be taken with the digital files and photographs taken on the Wedding Day, the Photographer limits any liability for loss, damage or failure to deliver photographs for any reason on behalf of the Photographer, agents, assigns or licensees for their non-performance caused by any force or similar circumstances, illness, accident or any cause beyond their control; nor for the loss or damage of any photographic materials, whether in transit or in processing to return of all money paid by the Client. In any event, the limit of the Photographer's liability shall not exceed the contract price herein.
3. EXCLUSIVE PHOTOGRAPHER: It is understood that no other photographer, amateur or professional, shall be allowed to photograph at the wedding near the Photographer while he/she is working due to reasons of the Photographer delivering the quality of images as expected. Any breach of this agreement can constitute a reason for non-completion of the job with no liability to the Photographer.
4. OWNERSHIP OF DIGITAL FILES: It is agreed that a copy of the digital files will be transferred to the Client, with ownership and copyright of the original digital files staying with the Photographer. Printing images outside of those included in Wedding Packages are subject to additional fees as specified in the Aduro Photography website.
5. DISPLAY PROMOTION: It is agreed that the Photographer may display and use photographs from the Wedding day for advertising, display, website and internet promotion, photographic contests, bridal shows, public display as in malls, photography books, photography instructional books, store fronts, window display, television advertising, magazine advertising and any other purposes thought proper by the Photographer.
6. RESERVATION DEPOSIT & PAYMENT SCHEDULE: Upon signature, the Photographer (Al Del Degan) reserves the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Reservation Deposit of 20% of the total price is non-refundable, even if the date is changed or the wedding cancelled for any reason, including acts of God, fire, strike and extreme weather. The Reservation Deposit is to be paid at the time of the parties signing this Contract. The Reservation Deposit is applied towards the contracted wedding photography package upon completion of this Contract. The Client understands and agrees that the entire amount owed for the wedding package described in this Contract is due on the day of the Wedding prior to any photos being taken.
7. GUARANTEED DELIVERY: The Photographer agrees to have the contracted order for wedding photographs completed within 4 weeks from the Wedding Day. Also any other photographic orders will be completed within 4 weeks of order placement.
8. INDEPENDENT CONTRACTOR: This Contract is not to be construed as an employment agreement in any way. The Photographer functions as an independent contractor.
9. CANCELLATION: In the event the Client must cancel the contracted services for wedding photography on the Contract, the Photographer agrees to refund all money paid, excluding the Reservation Deposit.
10. EXPENSES: The Client is responsible for all travel, accommodation, meal and transport costs unless otherwise noted in the Contract.
